Our mission is to **provide factual and complete information** regarding health protocols and vaccinations for children.




We seek to help children, and their parents and guardians make better informed decisions on **child vaccination against COVID-19.**

You gain clarity when what you see and hear with your own eyes and ears, matches what you are being told. We've reached out to a concerned parent and advocate for child safety to learn what she knows about COVID-19 and the recent **COVID-19 child vaccine rollout.**

Prior to the vaccine rollout, has there been a child infected with COVID-19 within your immediate community and have they suffered from severe illness or been hospitalized?

*I know many children who have tested positive for COVID, and their symptoms were similar to a cold, but **they recovered really well; none of them attended the hospital.***

Do you believe medical research and data is still the best authority when it comes to your child's health?

*I would believe **medical research and data is more accurate than what I am reading on social media.***

Do you know anyone who has experienced side effects from the vaccine?

Yes. My daughter is in secondary school, and her friend has recently had the vaccine.** Immediately after the vaccine, she was watched closely for 20 minutes as that was the procedure. During the school day, she experienced a high temperature and severe sickness. She was sent home immediately. **She was off school for 4 days.

Do you think your child's body is strong enough to produce COVID-19 antibodies after contracting the disease?

*Yes. My daughter tested positive during the summer holidays and did not appear sick. **I feel better knowing she has the antibodies now, and she was clearly able to fight off the infection.***

Should authorities override parental consent when it comes to your child's health?

I believe parents have the right to decide what is in the best interests of their children's health. If a parent needs support to make decisions, then it's the duty of the government to provide all the correct information to help parents make these decisions.

*I don't believe a 12-year-old child understands the serious health implications surrounding any vaccination, but **it's important for parents to discuss the issue with children and share all the data they have found.***

Are you providing a safe space for your children to openly voice out their hesitation with you in relation to the vaccine?



After a lengthy discussion with my 14-year-old daughter, she showed me her source for researching vaccine information, and I showed her credible search tools to look at statistics and data.

I was very concerned when I looked at the content as it discussed children keeping secrets from parents and stated she could get the vaccine and not tell me about it.

I was shocked as I believe it's important for teenagers to talk to parents, confide openly, and not keep secrets. I explained to my daughter if she received the vaccine without my knowledge and experienced a documented side effect, I would overlook the severity through lack of knowledge.
